Along with the completed Shared Residence Affidavit on the reverse side, you must provide the following documents:

#### OWNER OF RESIDENCE MUST PROVIDE:

The following 3 pieces of information from the person who owns/rents the residence:		
Copy of monthly mortgage statement or lease/rental agreement.		
AND		
Copy of current (with in 30 days) PG&E or Roseville Electric Bill that <i>shows service</i> and mailing address. PHONE AND CABLE BILLS ARE <b>NOT</b> ACCEPTED.		
AND		
COPY OF CALIFORNIA DRIVER'S LICENSE must show current living address (CA Vehicle Code sec. 14600 see below)		

#### PARENT MUST PROVIDE:

The following 2 pieces of information from the Parent/Guardian:
COPY OF CALIFORNIA DRIVER'S LICENSE/ID CARD must show address where you are living (CA Vehicle Code sec.14600 see below)
AND
COPY (1) OF BILL OR PAYROLL CHECK OR GOVERNMENT CHECK must show with current address

All Shared Residence Affidavits may be verified by the RJUHSD school Resource Police Officer.

### California Vehicle Code Section 14600

- 14600. (a) Whenever any person after applying for or receiving a driver's license moves to a new residence, or acquires a new mailing address different from the address shown in the application of in the license as issued, he or she shall within  $\underline{10~DAYS}$  thereafter notify the department of both the old and new address. The department may issue a document to accompany the driver's license reflecting the new address of the holder of the license.
- (b) When, pursuant to subdivision (b) of Section 12951, a driver presents his or her driver's license to a peace officer, he or she shall, if applicable, also present the document issued pursuant to subdivision (a) if the driver's license does not reflect the driver's current residence or mailing address.
