## Roseville High School Senior Conduct Policy

**Senior Conduct** (Board Policy 6147.1) is in place as an effort to ensure that seniors maintain academic progress toward graduation, attend school, display appropriate behavior, and exhibit sound decision making.

Our goal is that every senior enjoy a successful senior year at Roseville High School. Senior Conduct exists as a means of helping seniors understand that a diminishing academic effort, poor school attendance, inappropriate behavior, or bad decision making could result in losing privileges, missing the graduation ceremony, or more importantly, failing to earn a high school diploma.

Students may be placed on Senior Conduct for one or more of the following reasons:

### SENIOR CONDUCT FOR ACADEMICS

- ◆ Received two or more "F" grades in any course at the conclusion of a quarter grading period (final grade).
- Failure to successfully complete the District Personal Finance graduation requirement by the end of the third quarter of the school year.

#### SENIOR CONDUCT FOR ATTENDANCE

- ♦ 16 or more UNEXCUSED or UNVERIFIED period absences during any quarter grading period.
- 10 or more total **TARDIES** during any quarter grading period.

### SENIOR CONDUCT FOR DISCIPLINE

◆ Any **suspension** from the regular school day (including OCS) for any offense during the school year.

### What does this mean?

Seniors on **Student Conduct will not be allowed to participate or attend** any school related extracurricular activity. **This currently excludes athletics and athletic events**.

Student Conduct placement applies to the current quarter grading period.

♦ Example: Student earns an "F" at the end of the 3<sup>rd</sup> quarter. Student is placed on Student Conduct for the 4<sup>th</sup> quarter grading period.

### **How to be removed from Senior Conduct:**

- ♦ Seniors may **earn** their way off Senior Conduct by noticeably improving their **attendance** (<16 period absences) and/or **grades** (passing all classes) over the next quarter.
- ♦ Seniors may **appeal to the Senior Conduct Committee** due to a situation beyond the student's control or with a compelling explanation. A compelling explanation or situation is defined as an unforeseeable, unavoidable and uncorrectable act, condition or event that may have caused the student to be placed on Senior Conduct.
  - o Seniors on Student Conduct for Discipline must appeal to be considered for removal.
  - o Appeal forms may be downloaded from the RHS Website: <a href="http://rhs.rjuhsd.us/page.php?17">http://rhs.rjuhsd.us/page.php?17</a> or can be picked up from the Student Services Window.
  - o Appeals must be submitted prior to the final day of Senior Conduct Committee dates.

The RHS Administration will notify any senior student placed on Senior Conduct for any of the previously described reasons in writing.
