Beginning with the November 2022 Board member elections, Roseville Joint Union High School District (RJUHSD) Board members will begin the transition to being elected to the Board by-area instead of at-large. This means that instead of Board members residing anywhere within RJUHSD boundaries, there will only be one Board member in each of the five specific voting areas.

The RJUHSD Board voting areas mapping process is taking place now and utilizes the services of a Demographer to create draft maps of the five Board member voting areas. Over the next two weeks, the public is encouraged to create five voting areas with the use of Demographer's paper tools. To participate, please visit the RJUHSD's website <u>School Board/Elections Mapping/Districting</u>. This mapping period is December 21, 2021 through January 4, 2022.

All proposed maps (Excel Results) must be emailed (<u>ljungsten@rjuhsd.us</u>) or mailed to the District Office by January 4, 2022 in order to be considered by the Demographer in the draft maps to be presented at the January 13, 2022 Board meeting.
