Annual Notice of Expected Pesticide Use

Dear Parent or Guardian:

The Healthy Schools Act of 2000 requires all schools to provide parents or guardians of students with annual written notification of expected pesticide use at school sites. Information about pesticides and pesticide use reduction can be obtained at the following internet address: <http://apps.cdpr.ca.gov/schoolipm/>.

The Roseville Joint Union High School District has a safe pest management program. Our strategy has been focused on prevention of pest problems using no chemicals whenever possible and/or to use the pesticide chemical that is least toxic. Regardless, all applications of pesticides are done in a manner that minimizes exposure and risk to our students.

Parents/guardians who wish to receive notification of individual pesticide applications at their student's school site need to check the appropriate box on the Authorization Tab during the HomeLink data confirmation process. Those who check the appropriate box will receive at least a 72-hour notification prior to pesticide application.
