## Affidavit of Residency

**Providing false information about a student or parent/guardian's residence will result in immediate disenrollment from the school and referral to the school where the student & parent actually resides in accordance with Roseville Joint Union High School District Policies on student attendance. The District will contact law enforcement agencies when individuals are determined to have provided false or misleading information.**

**Please be advised that the District does verify residency using a variety of methods including checks of public records, visits to the residence, and photographs or video recordings of public areas.**

*Persons who provide false information under penalty of perjury are subject to criminal prosecution for perjury which is punishable by a fine and/or prison term of up to four years in state prison. (Family Code §6552; Penal Code §118, 125)*

*Persons providing false information under penalty of perjury also may be civilly liable for fraud, negligence and misrepresentation. Parties found civilly liable may be required to pay all damages caused to the District as a result of providing false information, as well as punitive damages. (Civil Code § 1709)*

*Persons who induce, obtain or otherwise solicit another person to provide false information on an affidavit are subject to the same criminal prosecution, fines, and imprisonment as the person directly committing perjury. (Penal Code §127)*

## INSTRUCTIONS AND REQUIREMENTS – PLEASE READ

**A Shared Residence Affidavit needs to be completed if a family is living with a third party *within* the Antelope High School boundaries.**

Along with the completed Shared Residence Affidavit on the reverse side, you must provide the following documents:

### OWNER OF RESIDENCE MUST PROVIDE:

The following 3 pieces of information from the person who owns/rents the residence:

\_\_\_\_ Copy of current monthly mortgage statement, most recent Sacramento Property Bill or current and valid lease/rental agreement, in the name of the primary owner/renter.

AND

\_\_\_\_ Copy of current (within 30 days) PG&E, SMUD or Water Utility Bill that *shows service and mailing address in the name of the primary owner/renter.*

**PHONE AND CABLE BILLS ARE NOT ACCEPTED.**

AND

\_\_\_\_ COPY OF CALIFORNIA DRIVER'S LICENSE **must show current living address**  
(CA Vehicle Code sec. 14600 *see below*)

### PARENT MUST PROVIDE:

The following 2 pieces of information from the Parent/Guardian:

\_\_\_\_ COPY OF CALIFORNIA DRIVER'S LICENSE/ID CARD **must show current residence address.** (CA Vehicle Code sec.14600 *see below*)

**All Shared Residence Affidavits may be verified by the RJUHSD school Resource Police Officer.**

### California Vehicle Code Section 14600

14600. (a) Whenever any person after applying for or receiving a driver's license moves to a new residence, or acquires a new mailing address different from the address shown in the application of in the license as issued, he or she shall within 10 DAYS thereafter notify the department of both the old and new address. The department may issue a document to accompany the driver's license reflecting the new address of the holder of the license.

(b) When, pursuant to subdivision (b) of Section 12951, a driver presents his or her driver's license to a peace officer, he or she shall, if applicable, also present the document issued pursuant to subdivision (a) if the driver's license does not reflect the driver's current residence or mailing address.
