## New Student Enrollment Information

---

Our district has implemented a new process to streamline registration. Therefore you will now need to register your student online at our district's webpage. <https://rosevillejuhsd.asp.aeries.net/air/>

In addition, you will need to bring all required documents to the high school in order to complete the enrollment process. Make sure you bring copies of all required documents, **incomplete and missing documents at the time of our student's registration, you will be asked to return at another time when you have all items.**

### Residence Verification:

- A. **COPY OF CURRENT** MONTHLY MORTGAGE STATEMENT OF **CURRENT** LEASE/RENTAL AGREEMENT.  
Proof must show mailing and property address. We cannot use rental applications; offer to purchase contracts, etc. Lease or rental agreement must be in the name of the parent enrolling student, must not be expired and show signatures of all parties.
- B. **COPY OF CURRENT** PG & E, SMUD OR WATER BILL  
Bill must show both mailing and service address. **Bill must be current within the last 2 months and must be in the name of the parent enrolling student.** \*\*\*Phone/cable/satellite bills are NOT acceptable.\*\*\*

***\*\*Please note that falsified documents will result in immediate disenrollment of student\*\****

**IMMUNIZATION RECORD:** **Without this proof your student will NOT start school.** Parents must provide a copy of **complete immunization records**, including Tdap (whooping cough) booster after the age of 7 per CA state law AB 354, at the time of enrollment to the school that student will be attending. Contact the high school nurse for exemption information or further questions. (California Health and Safety Code, §120325-120380.)

### **Additional Documents which may be required:**

**PRIOR HIGH SCHOOL ENROLLMENT:** Students enrolling in 10<sup>th</sup> – 12<sup>th</sup> grades MUST provide a copy of an unofficial high school transcript and a withdrawal form from previous school.

**SHARING A RESIDENCE:** A "Shared Residence Affidavit" form is required if a student is living with the parent/guardian and residing in the home of another person/family. The parent/guardian and the owner/lessor/renter must provide copies of picture identification.

**ALL SHARED RESIDENCES ARE VERIFIED BY ANTELOPE SCHOOL RESOURCE OFFICER OR ADMINISTRATOR.**

**LIVING WITH A GUARDIAN/CAREGIVER OR RELATIVE CAREGIVER:** If a student is not living with the parent/guardian then a "Caregiver's Authorization affidavit" must be completed by the receiving caregiver. The receiving caregiver must provide a copy of picture identification. ***These situations may require Administrative review before enrollment can occur.***
